AMENDMENT TO DECLARATION OF RESTRICTIONS

KNOW ALL MEN BY THESE PRESENTS:

That MELVIN ZUCKERMAN and ENID ZUCKERMAN, husband and wife, and ARENA, ZUCKERMAN & ASSOCIATES, being the owners of more than seventy-five (75%) per cent of the lots located in SABINO VISTA HEIGHTS, a subdivision of Pima County, Arizona according to the official map or plat hereof, of record in the office of the Pima County Recorder in Book 21 of maps and plats at page 6 thereof, in accordance with Paragraph No. 18 of that certain Declaration of Restrictions dated April 25, 1972 and recorded in the office of the Pima County Recorder on April 25, 1972 in Packet Book 1137 at page 490 to hereby amend said restrictions as follows:

All references to Lots Nos. 10 and 56 are hereby deleted and removed from the second paragraph, Restriction No. 4. Said Lots Nos. 10 and 56 shall be subject to all of the remaining provisions of said Declaration of Restrictions except as herein modified.

Other than as above set forth, said restrictions shall be amended, remain in full force and effect.
